It gives me immense pleasure that BTS has completed 37 years of journey working with disadvantaged and backward poor, marginalized, scheduled caste, forest-dependant and fishermen communities, small farm holders in Sundarban deltaic region towards securing lives and livelihoods. This year was significant with new era of sustainable development with empowering communities towards rights and entitlements, Climate-Smart(Resilient) and eco-friendly scopping and landscaping.

It's for special attention of our kind-hearted development partners and charity sponsors to think of the plights of the suffering community people living deplorably in the remotest border villages of Sunderban while they do not have any proper health care facilities due to absence of any PHC(Primary Health Centre) in Moipith-Baikunthapur GP as one of our area of operations and suffering mothers & children are to cover about 30 Kms to reach the BPHC at Jamtala, Kultali Block HQ. We are making humanitarian appeal to come forward to extend supports so as we can start our existing Health set up for community health & vision care opportunities.

To bring changes in the socio-economic standards among the ultra-poor with a massive trend/tendency towards out-migration to Indian metro-cities in search of daily-wage earning and manage their families under uncertain realities and abject poverty, BTS is keen to undertake small-scale livelihoods promotions to stop the evils of out-migration and human-trafficking including women & girl children. Food Security through agricultural promotions alongwith allied fields of interest to develop Agro-Entrepreneurs and setting up of FPOs(Farmers' Producer Organisations) to enhance agro-production planning as per suitable Crop-Calender vis-a vis building market-chains with ample clarity towards farmers' rights and entitlements, particularly Women-Land Rights(WLR).





## **History of BTS**

In 1978, a group of young people formed Baikunthapur Tarun Sangha as a village youth club for recreational activities for the youths of Baikunthapur village and its adjacent areas of Kultali Block under South 24 Parganas district, West Bengal. In 1982 a massive flood hit the Mpipith island and the youngsters, observing the situation immediately rushed to the flooded areas to help victims through shifting them into safer places, providing them relief with food, water, medicine, blankets & clothing etc. as well as pleading Government for relief and support. These unemployed youth didn't have resource for such services; yet begged donations & subscriptions from the people with their passion. The youth were struck by the extent of poverty amongst the people on one hand and total lack of apathy and support from others. They realized the vulnerability of the people and need to contribute towards organized community development efforts. Thus the resolve to work towards building better facilities for the people in need and thus **Baikunthapur Tarun Sabgha** in brief **BTS** was born.

## Operational area

The organization is operational in 24 villages of four (4) Gram Panchayats under three (4) community development blocks; namely Kultali, Patharpratima, Basanti & Namkhana of South 24 Parganas district of West Bengal, India, covering the total population 193,976 directly giving benefits to about 23,753 population.

Sunderban mangrove biosphere has been considered a highly productive ecosystem. This forest globally recognized for its wide biodiversity of mangrove flora and fauna both on land and water and is of immense scientific, anthropological and archaeological interest. It provides a wide range of valuable forest products, maintain estuarine water quality and play crucial role in the life cycle of many commercially important fishes.



Besides these, the acute disgrace of natural disasters like flood & Cyclone, vulnerabilities and other hardships are making the delta people under uncountable impoverishment and exploitation. Absence of sufficient alternative livelihood opportunities is compelling the young population to out-migrate towards metropolitan cities like Kolkata, Bangalore and Mumbai etc.Lack of Regular Electricity with sufficient voltage supply; exclusive bad roads without metal and waterway distance are making the area far-flung and cut-off from other lights of the age.Typically absence of basic healthcare services through PHCs and CHCs with proper emphasis of Maternal Child Health with nutrition care, care to the old and feeble, Illiteracy among the Scheduled Caste and particularly Schedule Tribes are very poor.

Now a day, due to absence of climate resilient measures, massive depletion of ground water strata rapidly as people using ground water for irrigation during winter and summer, trafficking among women and adolescent girls, prevailing domestic violence against women and girl child are the emerging issues in the locality to address.


## **Sustainable Agriculture Project (SAP):**

As Post-Aila Food Security initiatives through Land Reclaimation & bio-farming techniques

development process in the aila-affected 24 target villages in 2 coastal CD Blocks-Kultali & Patharpratima, Sunderban, BTS has been implementing having support of **AID** (Association of India's **Development)**, **USA** with the purpose of promoting chemical free agricultural practices by building capacities of small and marginal farmers on preparation and using of organic manure,



bio-fertilizers and pesticides with available local resources. There is



chains of agri-produces to Kolkata and other outlets to enhance economic sustenance.

Farmer's trainings were organized at Farmers' School of Learning-Kisan Pathshala on the issues of resisting salinity of soil; promote greening, river-mud analysis, IPM/ICM etc. Farmers' Eco-Clubs have been formed to challenge the issues upcoming as a result of Climate Change. The organization is continuing 'Farmer's school of learning' for management of local natural resources and this has been proved as best means of learning on bio-farming and bio-



diversity conservation in the sphere of Climate-Smart (resilient) farming-community development to adapt/address climate-shocks like cyclone or floods which is very common in Sunderban.

# **Child Protection & Quality Education**

## **BTS-PathBhavan School**

BTS-Path Bhavan, a model school is running by the organization since 1983 for needy, poor and

first generation learners. BTS-Path Bhavan is the first initiative as model school with joyful learning facilities in Kultali CD Block. Presently, there are **200 students** in Six Classes from Preparatory(LKG) to Standard –IV. In addition to Joyful Learning, the children are given cooked food as nutritional and healthcare support, vocational skills (making chalk, mud dolls, seating mats), computer literacy, exposure visits, bio-diversity and climate change education as part of Environmental Education are also included in course curriculum. BTS also included in curriculum that promotion of hygiene





education, save water campaigning, hand washing, etc. Safe drinking water and sanitation (WASH) facilities through construction of School Sanitary Blocks both for boys and girls in the school has enhanced the health and hygiene habits of the students. In addition to that, landscaping and beautification of the school premises by planting of flower-trees not only adds to the aesthetics but also provides a cheerful and nurturing environment.

BTS has been managing a child-friendly and valu-education based classrooms with recreational and joyful learning arrangements. The newly introduced Child Parliament has been formed towards regular monitoring on mid-day meals nutritional opportunities supported by SAVE-UK & HNF-CAF through Smile Foundation, water, sanitation & hygiene, games & cultural events, solid waste management with



segregation of wastes. **Asha for Education– USA and Smile Foundation** both are supporting this model school program for a longtime partnership. BTS is also running a well-equipped **Children Resource Library** for the school students. BTS also provides free books to students, school uniforms, hygiene materials, etc. for enabling the poor parents' economic burden- free and to

send their loving ones to regular schooling without involving them in the livelihood activities like

fishing, crabbing and small farming. The monthly health check-up with free medicines, promotion of Yoga & Meditation, AYUSH are also continuing for the students in school.

Beside these , BTS-PathBhavan has been imparting computer education through its **Computer Literacy Program(CLP)** having supports from **Medha(Kollol Women Forum)**, **USA**. Interested children are given training both on theory & practical classes in 3



days/week. A good trainer, a brainware student, from the locality is there to make the children smart in learning computer with digital literacy.



# **BTS-Pre School centres & Project Samannay with ICDS**

Project ICDS-Sammanya (a collaborative and innovative project with Anganwad iCentres of



Integrated Child Development Scheme of Govt.) is continuing with 28 AwangadiCanters in both Kultali and Patharpratima Block since 2009 with the support of BIBHA-USA. The main purpose of the project is to develop mental, physical and social growth among preschool aged children attending in anganwadicentres. BTS's intervention in the project is to minimize the gaps for running anganwadicentres. All the gaps (irregularities of attendance, services, inadequate infrastructures, monitoring, etc.) are identified collectively with

government, panchayats, parents and Anganwadi Workers. BTS organizes monthly health check-ups with medical doctors and Yoga for children by engaging expert. BTS provides numbers of trained staffs, preparation of participatory TLMs and using TLMs in centres. Besides these BTS also organized Anganwadi Workers trainings, awareness sessions for mothers, support on nutrition gardening, etc.



02 nos. of **Crèche cum Pre-School Centre (PSC)** are running for the children of working parents since

2002-03. Total 50 children are attending regularly. The project is under the Rajib Gandhi National Crèche Program, WCD, Central Social Welfare Board in collaboration with Directorate of ICDS and Women & Child Development, Govt. of West Bengal.

**Bibha-USA** is also supporting to both centres since 2012-13 for the enhancement of quality of the centres by providing uniform, TLMs, teachers trainings, nutrition supplementation, etc.

# Sustainable Livelihoods & Women Empowerment

Project JibanJibika (Livelihoods Development) a sustainable livelihood intervention program for the marginalized widows of tiger & crocodile affected families and ultra-poor widows by supporting livestock assets e.g. poultry birds and goat rearing. The project is supporting by People Progressive in India (PPI), USA. Total 451 widows were supported (Goatery-100 & Poultry Birds-351) during last three years. During the reporting year BTS made an impact study on improvement of livelihood of such families that supported with livelihoods assets. The overall impact of the program is enhanced income by selling goat-kids, eggs and chicken. It has also been observed that a few (8%) of the beneficiaries supported with poultry birds are not able to enhance income due to mortality of birds. All the goats supported beneficiaries have increased income of Rs. 8,000 to Rs. 12,000 by selling goats.

**Project Swabalamban(Self Reliance)** is the continuation in coming years with value addition of interventions like skill development in wood craft and repairing of two wheelers motorbike alongwith poultry & Goat farming for youth of tiger and crocodile affected families and enhance income from livelihood assets being provided a part. The project would be continuing upto September in 2020 and next there are 2 years more to work on the initiatives



with target achieved towards self-reliance and economic stability.

# Community-Based Disaster Risk Reduction

Bread for the World (BfW) and CASA-New Delhi supported "Sustainable life and livelihood of rural people through promotion of community based Disaster Risk Reduction in Sundarban deltaic communities" since October 2015 to March, 2019 as first phase of the operations. The overall goal of the project is "Women and men are empowered and adopted livelihood resilience models to attain food security through collective and sustainable approach in the disaster prone Sundarban



deltaic villages". The project is implementing in 05 villages of Kultali Block with coverage of 530

numbers of most vulnerable marginalized families. The major intervention of the project is building capacities among the members of various community organizations and groups to secure rights and entitlements.

The following community based organizations and groups have been formed capacitated in participatory planning, implementation, advocacy & lobbying skills, disaster risk reduction measures, control of violence against women & girl child, economic and gender awareness, etc.

Social, Economical and Ecological changes observed as our beneficiaries are mobilising resources from the PRI(self Govt.) & different income generating efforts are initiating alongwith conservation of environmental issues.

<u>Social Change:</u> the intervention communities are specially Minority and Poor dominated areas. previously people were not aware about the govt. facilities, their entilements and benefits which they can access. but, after conducting some sensitization meetings on different govt. schemes like - Old Age Penssion, Widow Penssion, JSY, SASPFAU, MGNREGA & PDS under NFSA, people are comming out of their own interest and voluntarily discussing on the issues and problems pertaining in accessing the benefits.

Community people orineted about the role and function of Gram Sansad in the village. Targeted beneficiaries are oriented on same and assured to take active part in it.

**Economical Changes:** The rural areas of Sundarvan are represented by the territories outside the adminastrative boundaries of the cities varios types of villages boroughs and their environs with a certine population ,difinte living conditions, mode of life , based on regional culture and spesific activities. Sundarvan has good condition for developments of agriculture and rural settelments , suficiant agricultural resource and their natural productivity , a high proportion of reclaimed lands, and climatic conditions,which are suportive of Dairy , Poultry and Meet Farming ,vegitables,etc. during this reporting period ,BTS conduct some demand based training programme at BTS centrally .like Poultry, Gotary, and some farming like Floating garden ,Hemline Garden and Nutrition Garden through organic process .

<u>Ecological Changes:</u> People of Sundarban is basically dependent on mangroves. In their daily life, community people used to cut the mangrove tress and use the same as fuels as, their primary source. Due to lack of protection and conservation of mangrove became a challenge for the organization. during this reporting period, organization conducted some awareness generation meeting on the benefits of mangrove protection and conservation. to some of the extent, community people knew the benefits of mangrove protection, and the ill effects of deforestation of mangrove and also effects on climate change for cutting down the mangrove tress from the river bank areas.

The changes have been measured with following indicators

- i. Atleast 500 beneficiaries from tar-get villages are having access to existing Govt welfare schemes [like NREGS, JSY, ICDS, Enrolment in Schools, IAY, etc].
- ii. DRR Plan is in place in all 5 targeted communities along with active presence of 5 DMTF (Disaster Mitigation Task Force) team at respective community.
- iii. Women are actively participating in governance process & in household decision making.
- iv. Women are actively participating in governance process & in household decision making.
- v. Organization is develop one Gender Mainstreaming Policy and ensures proper execution

The second phase of the project is continuing for another five years w.e.f. from April 2019 with increasing the numbers of beneficiary families from 530 to 600 in all five existing villages.

<u>Women SHGs & Cooperative:</u> BTS organizes women Self-Help Groups (SHGs) and later has promoted a women cooperative society –**Kultali Mahila Bikash Co-Operative Credit Society Ltd.(KMBCS)** with the recognition of **ARCS, Govt. of West Bengal**. This Women Cooperative has initiated various activities like; managing bank with credit, savings and depositing. Beside this, making sanitary napkins and trading towards promoting menstrual hygiene among rural women and adolescent girls, various income generating trainings for women.

# **Climate Change Adaptations & Bio-diversity**

# A. WWF – supported project on Bio-Diversity Conservation and Climate smart livelihood promotion:

WWF supporting BTS for implementing few study-related projects like Energy Access Study, Fishermen Social Study, Fishermen Livelihoods (landing & House Holds Studies in this FY 2018-19 alongwith the current project on conservation and regeneration of bio-diversity through building resilience of the forest communities in Sunderban from March 2019 onwards. During the reporting year, BTS implemented climate change and climate smart alternative livelihood intervention to forest and river dependant marginalized families in Deulbari Gram Panchayat under Kultali CD Block, South 24 Parganas. Total 83 Numbers of forest-fringe, forest-dependent families supported with integrated farming in an organic manner, backyard poultry, duckery, goat rearing, homestead plantation, etc.

### B. Sustainable Water Resource Management(SWRM)

We all knows that rain water is only source of water. The infiltration of rain water increases ground water strata that uses for human consumption of people living in Sundarbans by fetching water through tube wells with hand pumps. But, last 15 years the ground water is using in irrigation irrationally for the agricultural production. Farmers constructed bore wells

with bigger diameter of pipes and lifting water continuously by using motorized high horse power submersible pumps resulting that massive depletion (4 - 6 Metres) of ground water and many hand pumps are not working properly. Now a day, it is also observed that people used to take bath from tube well water it was not happening earlier as they all were went to ponds. So, misuse of water



is one of the major issues due to lack of awareness among people including farmers.

In this situation, people needs to be sensitized to save & reduce the misuse of water and to educate people through " Save Water Campaigns" in the operational villages in Kultali & Patharpratima blocks under Sundarban deltaic region. In collaboration with JGVK, Basanti and

having supports from UBU-Denmark through JGVK, BTS has started initiating the project intervention during the FY 2018-19.

C. Climate Change Adaptation – To build Climate-Smart Communities on various measures of Climate Change Adaptations like; promotion of climate smart agricultural practices, introduction of low water requirement crops, integrated water management techniques. Beside these, BTS also building awareness on save water and environmental regenerations among school children, SHGs and Community based organizations through IEC materials, role plays by involving school students and village meetings.

# Mother-Child Health & Nutrition +

BTS has continuous initiative promoting safe motherhood and child health care in distant island



pregnant women especially of high risk (HR) category and provide basic antenatal care and advice attending doctors for institutional care. BTS established one **Rural Community Hospital** through which institutional pregnancy & lactating mother cares are provided. **Telemedicines**, Outreach screening camps for

areas of Sundarbans, as there is no health institution for health care especially antenatal & postnatal cares. The organization has its own trained community health workers (CHW), supervisors and other supportive staff to provide health care support to the people of deprived communities. The community health workers conduct regular home visits, identify



high risk pregnant women are organized in the communities and referred HR pregnant women to health institutions for special care(s).

BTS has been conducting Medical Camps with general physicians & specialist doctors and the suffering mother & children including common community people are getting treatment facility. **Peerless Group CSR** Deptt. Has supported this **Medical Camps initiatives** here in Kultali, Sunderban.

BTS has started Tele Medicine Services to the suffering patients in collaboration with **Arogya Bahini Trust, Kolkata** having supports from **Tata Trusts**.





# **School Wash & Safe Adolescence**

**Kolkata Gives** is with BTS to lead the women SHG-Sundari to manufacture Sanitary Napkins in a low-cost manner to supply rural adolescent-girl children towards Safe Adolescence and even to



bearing educational expenses to them a dream indeed. BTS presently supplied to 1550 rural girl school goers at adolescent stage at Rs. 5/- only per 2 packs per month with supports from **Sneh** 

poor housewives at a cheaper rate than market price not usually affordable for them due to their low-incomeor absolute impoverishment. Sanitary Napkins..! while



Foundation, Kolkata. BTS SNPU has started to supply the napkins from the month of July 2018 and

it has become a great effort for BTS to empower and facilitate the whole process to bring Sundari in the local market.

BTS has been exploring financial supports from any donor/CSR to work on School WASH by improving WASH infrastructures in the high schools in Kultali where the WASH infrastructure is very very low and typically absent and it's a complete threat to safe adolescence particularly in the coastal block of Kultali, Sunderban. Running Water supply to toilets, wash rooms,



poor condition and absence of toilets and wash rooms, disposal rooms, change rooms etc. are essential needs in the schools here.

# Care of Older People & Safe Sights Program

In collaboration with **Sneh Foundation**, **Kolkata** we have initiated the **OSP(Oldage Support Program)-Ashahay Bardhakshya** to be a part of the oldage people living in a very miserable





situation out of our imagination. BTS has started to provide 20 such old and feeble in Kultali and supplying monthly basis a package of foodgrains including rice, dal, edible oil, nutrela, potato, Atta, puffed rice(Muri) etc. for 30 days. There are 100 such helpless oldage people who need your kind support to keep themselves fed with care and concern so that the old and the infirm may find solace to think of a world of love & friendship.
