This year we witnessed a disaster in terms of our health and safety; a pandemic COVID-19 spread his perilous legs all over the world. Whole country was stubborn following the pre and post lockdown. Many job sectors were forced to be closed and many sectors were found to be empty handed. During these tough phases **JanMitram** stand tall among all the adverse scenarios. Projects like Wadi, E-Shakti, SHPI programme moved ahead even in challenging surroundings while number of Self Help Groups (SHGs) increased by a good margin.

JanMitram always tend to perform better and better every year in every aspects of our mission. In our livelihood and environment protection vision we have arrived in phase III of Wadi Programme by engaging more farmers in production of horticulture crops instead of only vegetables and regular crops such as rice, wheat and maize. As result, we helped more families in increasing their annual income.

In our Natural Resource Management vision, we have completed one project and submitted a report to concerning agency. The FSR project was implemented in 11 districts of Chhattisgarh under 32 different projects. We were praised by the support staff and by funding agency considering our qualitative evaluation work.

Awareness programme on HIV-AIDS has arrived into its 11th year with numbers always increasing in support of this programme. Number of SHGs and participation of new peoples in each blocks are quite encouraging for our SHPI programmes.

Brief summary of the project

About Livelihood and Environment Protection

Livelihood enhancement remains the core of all our accomplishments. Livelihood and environment protection along with poverty elimination are the core issues our accomplishments in our vision path. We are operating different programmes related to livelihood to achieve the endeavor among such initiatives. In the process, we have implemented WADI program in Gharghoda block of Raigarh district in collaboration with MGNREGA and Horticulture Department Raigarh for plantations.

Programm Wadi Development (WDP)- Phase III

'Wadi' originated from a Gujrati word, has a vision to provide shelter and income to tribal people. A program started in the year 2011 is successfully running into three phases. **JanMitram** has successfully created **1,225** Wadies so far with prime support of NABARD. The notable achievement in this programme are development of barren lands into fertile lands; farmers grew only minor millets in certain patches of these lands which has resulted as their valuable assets. We trained farmers to plant the crops along with high yielding fruits verities as main crop and vegetables are grown as intercrop.

Field Operations in Wadi Phase III

Previous year 2018-19 we had successfully created 1,225 Wadis by planting a total of 67,375 plants of Mango (*Mangifera indica*), Cashew (*Anacardium occidentale*), Guava (*Psidium guajava*) and Lime (*Citrus aurantiifolia*). We provided all kind of water source at every wadi cluster. A total no of 62 bore well, 72 rings well, 12 no of pumps etc. Plant survival rate in these year is observed about 75-92% with development of land and water resource, intercropping has become popular.

In the year 2019-20 instead of developing new Wadis we kept our focus ourselves in renovation of existing Wadis. Many silvicultural operations such as site preparation, regeneration, weed control etc. were conducted in the field area. Table-1 shows production details of crops in the year 2018-19 and 2019-20.

A journey never completes without getting ups and downs. Similarly, in our Wadi programme some of the farmers faced extreme events during the course of time but they continued their hard work. We have witnessed some farmers getting success through our Wadi programme.

1. Tejraam Rathiya, age 46, village- Tenda, Gharghoda

'If You think positive you will lead yourself to self sufficient'

We are talking about Teejram Rathiya, who has large family consists of 09 members and solemnly dependent on agriculture. This family is getting benefits by our Wadi programme. The village Tenda is largely affected by elephants and in this village he had 05 acres barren land which was being used earlier for barely one season but now this land is being used for some horticulture crops such as Mango, Guava, Cashew and Lime. Seasoned vegetables are also cropped in the mean time. The programme not only helped in plantation of this fruits crop but also provided facilities for irrigation, pesticide and insecticides. Through proper nourishment and rotation of crops, soil quality has also been



improved. Through this programme, the family of Teejram Rathiya have able to increase the annual income to 1.50 lakhs from 60,000 Rs. The whole family is thankful to all members of **JanMitram Kalyan Samiti.**

Another farmer who was benefited from our programme is Raja Ram. Since his childhood poverty and lack of education forced him to live in poverty. The source of income was farming and labor works which cumulated to annual income of Rs 25,000-30,000/- ony. But Wadi programmed lead him and his family to beyond poverty. Since, the inception of this programme he continues to earn in profits by cropping horticulture crops with all kind of irrigation facility. Today his annual income has increased up to Rs. 1,00,000-1,20,000/-.To add to his additional assets he has his own tractor and motor cycle now.

Brief summary of the project

Integrated Watershed Management is restoration or maintenance of ecological balance by harnessing, conserving and developing degraded natural resources such as soil, vegetative cover and water. To fulfill this objective our organization is implementing a IWM project in Kharsia block of Raigarh district with the prime support of GOI-MoRD with collaboration with NAWABIHAN SAMITI.

The main objectives of the project is to provide soil and water conservation facility to each farmer through "one drop and more crops" theory. Till, date total 3,250 families are getting benefited through this program. 16 Micro watershed committees are running smoothly the project activities with their own capacity. The farmers are concern to construct such structures which will check soil erosion and improve water availability through natural resource management to sustain their life and livelihood in the block. Evaluation works were completed in 11 different districts of Chhattisgarh under32 different projects.



Our organization is implementing watershed development project in Kukricholi ,Tendumudi and Jampali villages of Kharsia block in Raigarh district . Within this project, we have covered area of 990 ha. in three villages. Under this project all the area to be treated within the time frame of five year. The total no of 3500 beneficiaries will be benefited under this project .The project have the two part one is watershed work and another part is livelihood enhancement. People's contribution of 16% is the major focus of the project for people's involvement in the project. The project has started in the year 2018-19. Currently we have completed the CBP phase of covering a area of 200.2 ha. under treatment.

Project Objectives : 1. To reduce the risks of HIV-Aids among sex workers in Raigarh

Duration : 11 years (2009-2020)

Targeted Intervention Projects (On Sex Workers): - The programme was initiated since 2009, **JanMitram** is engaged in a highly challenging programme for Targeted Intervention of Female Sex Workers, to reduce their risk of HIV-AIDs and STD infection. This project is running through prime support of NACO-National AIDS Control Organization, State Aids Control Society. Technical assistance is being provided by Hindustan Lever Family Planning Trust.

The organization has identified 1200 core groups (FSW +MSM + IDUs) in two towns. Both town have seen high industrialization, mining and thereby emergence of migrant workers and truckers. Overt and covert Sex-workers have increased accordingly, posing great threat of HIV spread in lower middle-income groups. Our primary target is to prevent spreading HIV and sexual transmitted infection among these FSWs through time-to-time awareness and and providing counseling, medicines, condoms etc. we are trying to rehabilitate because many women as possibly belong to other professions too. Brief summary of the project

Self-Help Group (SHG) is a small voluntary association of poor people, preferably from the same socio-economic background. They come together for solving their common problems through self-help and mutual help. The SHG promotes small savings among its members. The savings are kept with a bank. This common fund is in the name of the SHG. SHG is a group formed by the community, which has specific number of members like 15 or 20. This programme is specially designed for the Self Help Groups those are the backbone of rural development now a days. SHPI makes them economically, socially and psychologically strong. NABARD express an interest to nurture 500 SHG with the help of our organization.

In initial stage itself, we were able to form 490 SHGs in Dharamjaigarh and Chhal cluster of Dharmjaigarh block in Raigarh district. The SHPI programme is not only limited in creating SHGs or only for their awareness but it is also a platform to strengthen their economic status in terms of savings programmes and cost effective delivery mechanism. Our organization provides these SHGs bank linkage to avail the loans when needed for different purpose. Table- 3 shows the statistics of SHPI programme in 2018-19 and 2019-20.

This is one of completed projects in the financial year 2019-20. FSR report was submitted to the funding agency the sites were Kukricholi ,Tendumudi and Jampali villages of Kharsia block in Raigarh district.

Training Programmes in the year 2019-20.

Organizational Training Camp Training (OTC):-

Our organization implements different developmental awareness programs and camps time to time. This year 2019-20, we organized OTC (Organizational Training Camp) training with kind support of Zila Panchayat Raigarh in nine blocks of Raigarh district to enhance the livelihood of the tribes and general belongings.

Objective of the training was to make tribes aware about the existing policies of state government in rural areas. A total of 3120 participants from different villages participated in 2018-19. The training was organized in the JSPS school premises in Gharghoda as training centre. The trainees are from development partners in the panchayat level i.e. PRIs, BDCs, SHGs, Mitanins, Anganwadi members, MGNREEGA



grass root workers and eminent personality in the panchayat. An overview of OTC training in 2019-20 is given in Table- 5.

1. Janmitram SPS Memorial Sschool, Gharghoda

The school JSPS is running under the guidance of janmitram Kalyan Samiti in gharghoda block of Raigarh district presently it has 416 students in the school. Out of these 70 are the residential scholar who are residing in the premises as a hosteller.

The school has adapted 46 poor children to continue their education at free of cost. Those free scholars are getting education apart from RTE under government scheme. We are thankful to the people of Gharghoda who overwhelmingly responded to school and also to Give India Foundation which collected

sizable support through its website to open the school. Give India also provide the donation to JanMitram for school fees of poor, tribal and unprivileged children. We are committed to provide them high quality education.

In the year 2018-19 the school has got the affiliation from CBSE which is the only school in Gharghoda , in the development path the school has raised income from the collection and loan . new hostel special for girls and cantteen has started in th same premises . The school is committed to take 100 students as boaring in the JSPS school .

2. Give India Foundation Programme

Janmitram is getting fund from Give India foundation apart from Government fund. The fund is raised by Individual funders residing in India or abroad.
